- Associate Membership (\$135) – You are employed by a Board of Education, or a Contractor, as support staff for transportation.
- Associate Vendor Membership (\$150) – You are a recognized vendor that offers for sale products for the school bus industry and recommended by the Board of Directors. Each additional associate vendor from the same company would have dues of \$50 each.
- Honorary Membership (\$0) – You were a full member upon your retirement from the school transportation industry.
