Garden State Parkway to Exit 127 toward I-287/Woodbridge/Staten Island. Merge onto NJ-440S toward I-287. NJ-440S becomes I-287N. Merge onto State Route 27/NJ-27 S via Exit 2B toward New Brunswick. Turn right onto County Hwy-529/Plainfield Ave. 1660 Stelton Road is on the left.

**FROM NORTH**

I-287 South to Exit 5 – Stelton Road/County Hwy-529 toward Edison. 1660 Stelton Road is on the right.

**FROM THE NEW JERSEY TURNPIKE**

NJ Turnpike to Exit 9-NJ-18N toward US-1/New Brunswick/Princeton/Trenton. Stay straight to go onto NJ-18/Memorial Parkway. Merge onto NJ-27N toward Highland Park. Turn left onto County Hwy-529/Plainfield Ave. Continue to follow County Hwy-529. 1660 Stelton Road is on the left.
