## ABSENTEE BALLOT INSTRUCTIONS

---

1. Mark the ballot you received.
2. Fold the ballot and insert it into an envelope clearly marked "Absentee Ballot, June 10, 2016" and seal the envelope. Make no marks on the ballot or envelope to indicate who you are.
3. Insert the sealed envelope into another envelope addressed to STS of NJ, P.O. Box 66, Raritan, NJ, 08869. This addressed envelope must be clearly marked with your name. We suggest the return address, placed at the upper left corner of the front of the envelope, state your name. If your name is not clearly visible on the outside of the envelope, your vote will not be counted.
4. Mail the envelope so as to reach the P.O. Box no later than Thursday, June 2, 2016. That's at the Post Office Box by Thursday, June 2, 2016, not postmarked by that date. Please remember Federal Express and other commercial carriers cannot deliver to a Post Office box so please plan accordingly.
5. If you are able to attend the meeting, and you have requested an absentee ballot, whether you returned it or not, you will not be able to vote for candidates at the meeting. Stated another way, if you request an absentee ballot, as per the by – laws, you give up the right to vote for candidates at the General Meeting.
