### **Cinnaminson High School – 1197 Riverton Rd, Cinnaminson, NJ 08077**

#### **From the North**

Take NJ Turnpike S to Exit 4 – NJ-73 N

Keep left to stay on NJ-73 N

Use the right lane to take the NJ-73 N exit toward US-130/Tacony Brg

Continue onto NJ-73 N

Use the right lane to merge onto US-130 N/Burlington Pike via the ramp to Cinnaminson/Trenton

Use the 2<sup>nd</sup> from the right lane to continue on Burlington Pike

Turn right onto Riverton Rd

Take a slight left to cross Burlington Pike

Use the right lane to continue toward Riverton Rd

Turn right onto Riverton Rd

The destination will be on the right

#### **From the East**

Take NJ-70 W

Turn right onto Medford - Mount Holly Rd

Turn left onto Church Rd

Turn right onto Burlington County Rd 603/Mt Laurel Rd

Turn left onto E Main St

Turn right onto Chester Ave

Continue onto Riverton Rd

At the traffic circle, continue straight to stay on Riverton Rd

Use the right lane to continue toward Riverton Rd

Turn right onto Riverton Rd

The destination will be on the right

## **Directions**

### **Barnegat High School – 180 Bengal Blvd, Barnegat, NJ 08005**

#### **From the North**

Take Garden State Pkwy S to Exit 67A – Lighthouse Drive in Barnegat Township. Turn right onto Lighthouse Dr (signs for Co Rd 544 E/Barnegat)

Use the right 2 lanes to turn right onto W Bay Ave

Use the left 2 lanes to turn left onto Barnegat Blvd N

Turn left onto Bengal Blvd

The destination will be on the right

#### **From the South**

Take Garden State Pkwy N to Exit 67 -CR-544 toward Barnegat

Use the right 2 lanes to turn right onto W Bay Ave

Use the left 2 lanes to turn left onto Barnegat Blvd N

Turn left onto Bengal Blvd

The destination will be on the right

## Directions

**Wayne Transportation Dispatch Office - 101 Pal Dr, Wayne, NJ 07470**

**(Use North Cove Park as a landmark)**

### From the East

#### **Rt 80 W**

Rt 80 W to Rt 23 N. Follow the Service Road exit to Taylor Dr. Make a right on Taylor and follow to the end. Make a right on Pal Dr. Follow Pal Dr. to the end.

#### **Rt 46 W**

Rt 46 E to Rt 23 N, get off on the Service Rd exit. Pass the West Belt exit approx.  $\frac{1}{4}$  mile to Taylor Dr. Make a right onto Taylor to Pal, go to the end make a right on Pal, follow to the end

### From the West

#### **Rt 80 E**

Exit onto Rt 46 E, U-Turn at Riverview Dr to Rt 46 W to Rt 23 N. Follow the Service Road exit to Taylor Dr. Make a right on Taylor and follow to the end. Make a right on Pal Dr. Follow Pal to the end. (There is no exit to Rt. 23 N from Rt. 80)

#### **Rt 46 E**

Rt 46 W to Rt 23 N, bear right onto the Service Road exit to Taylor Dr. Make a right on Taylor, and follow to the end. Make a right on Pal Dr. Follow Pal to the end.

### From the North

Take 287 S to 80 E or 46 E. U-Turn at Riverview Dr to Rt 46 W. to Rt 23 N. Follow the Service Road exit to Taylor Dr. Make a right on Taylor, and follow to the end. Make a right on Pal Dr. Follow Pal to the end.

Garden State Parkway S to Rt's 46 or 80W, follow the above directions.

**\*For all the above directions if you miss the Service Road exit, take the next exit for Mountain View Blvd, Taylor Drive will be almost directly across to the left.**

#### **Rt 23 S**

Get off at the Mountain View exit. Make a right at the light onto Mountain View Blvd (Grasshopper will be on your left at the light) Follow around to the traffic light at Parish Dr. Make the left onto Parish and bear right immediately onto Pal Dr, follow to the end. Once you are on Pal Dr, pass the PAL building and ball fields on your right, there will be train tracks on your left, continue to the end, and you will see the buses. There's a small footbridge to the office building.
